## INSURANCE FOR NONPROFITS WORKSHOP:

Telluride Foundation Hosts Free Nonprofit Capacity Building Workshops

TELLURIDE, Colo. – (Feb. 22, 2024) While insurance may not sound like the most exciting topic for your nonprofit board meeting agenda or even one you want to spend your lunch hour learning about, it is essential for nonprofits and is as important as planning your next event, fundraising campaign, or budget. Nonprofits may require many different types of insurance, including directors and officers, general liability, automobile, property, fidelity, and more. To help nonprofits navigate the, sometimes confusing, world of insurance, the Telluride Foundation is hosting an "Insurance for Nonprofits" workshop. The workshop, taught by Darren Coltrinari of Home Loan Insurance based in Grand Junction, will be held via Zoom, on March 7th from 11:30 a.m. – 12:30 p.m.

This free event, taught over the lunch hour, is open to anyone wanting to learn more about insurance options, but nonprofit staff and board members are especially encouraged to attend. "There are many insurance coverages to consider as a nonprofit organization, and the task of reviewing coverage can be overwhelming," said Coltrinari. "Directors and officers coverage is a necessary policy for your board of directors, and a standard General Liability policy is a must, as well as the state requires Workers Compensation if you hire employees." In this workshop, Colrinari will elaborate on these standard policies and examine other common policies required by some funders.
